NOTES TO BE READ WHEN COMPLETING THIS FORM

- i. If there is a change of ownership of the aircraft, or if it is destroyed, permanently withdrawn from use, or sold abroad, Section I, II or III should be completed as appropriate and the Certificate of Registration must be returned immediately to the Seychelles Civil Aviation Authority, Safety Regulation Division, P.O. Box 181, Mahe, Seychelles.
- ii. The owner or charterer should sign personally; where more than one person is shown on the Certificate of Registration as owner, each person should sign. In the case of a Body Corporate or Undertaking, a Director, Secretary or other authorised officer of the company should sign, stating the position he holds in the company.
- iii. The attention of all persons completing this form is drawn to the importance of ensuring that the entries are correct. The making of a false statement for the purpose of procuring the issue of a certificate of registration is an offence under the Air Navigation Order.
- iv. When an aircraft or any legal or beneficial interest therein ceases to be owned by a qualified person the registration becomes void immediately and the Certificate of Registration must be returned at once to the Seychelles Civil Aviation Authority, Safety Regulation Division, P.O. Box 181, Mahe, Seychelles.
