# GUIDELINES & RULES

## Photography

1. Photographs must be in digital format. No print submissions will be accepted for entry into this contest. The files must be in .JPEG or .jpg format. Must be over 3000 pixels wide (if a horizontal image) or over 3000 pixels tall (if a vertical image).
2. Permission for use of drone must be requested from SCAA via email [msuzette@scaa.sc](mailto:msuzette@scaa.sc) copy [gsicobo@scaa.sc](mailto:gsicobo@scaa.sc)
3. Operators should contact SCAA control tower tel: **438 4191 / 438 4192** on the day they wish to operate their drone.
4. Photographs must be taken within 1 year of the date of entry and not have previously won an award on an International or National level.
5. Minor burning/dodging and colour correction is acceptable.
6. High Dynamic Range (HDR) and stitched panoramas are acceptable.
7. No full-frame close up work of other artists should be seen within the photos. The work of others must be as an object in its environment.
8. The photographs should be a single work of original material taken by the entrants of the competition. By entering the competition, entrants acknowledge, warrant that the submitted photograph is an original work created solely by the entrant, the photograph does not infringe on the moral rights, rights of publicity or intellectual property rights of any person or entity and that no other party has any title, claim or interest in the photograph.
9. Photography must not contain obscene, provocative, sexually explicit or objectionable content.
- 10. Photographs may be captioned and caption must link to the theme of the competition, which is 'We Are Tourism'.**
11. 3 submissions are allowed per entry.
12. Watermarked entries will not be accepted.
13. Entries with visible digital signatures will not be accepted.

Entries will be judged based on: Creativity; Photographic quality; and Genuineness and authenticity of the content. Decisions of the Judges will be final and binding.

Upon submission, note that photos will henceforth be property of the Ministry of Tourism, Civil Aviation, Ports and Marine. Photographers will be credited when their photograph is used.
